I warrant that I have no disability, impairment, or ailment which would prevent me form engaging in active or passive exercise, or that will be detrimental or adverse to my health, safety, or physical condition(Initial.)
I am voluntarily using the Fitness Center with full knowledge of the inherent risks and dangers involved and hereby assume and accept any and all risk of injury, paralysis or death, and agree to adhere to all rules and regulations governing the use of the Fitness Center, including any verbal or written instructions provided by the Association and /or its management(Initial.)
I, for myself, my heirs, successors, executors and superiors, hereby knowingly and intentionally waive and release, indemnify, and hold harmless the Association and its Management Company, or any of their officers, agents, affiliates, employees, contractors or volunteers, individually and collectively, from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney's fees) and negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my use of the Association's recreational facilities, including the Fitness Center, whether such damage, loss, injury, paralysis, or death results from the negligence or other acts however caused by or contributed to by the Association and all related entities named above, or from some other cause.
